(Approving Certification of General Election Results)

WHEREAS, Article VI of the Tribal Constitution of the White Mountain Apache Tribe requires regular elections to be held for Tribal Council; and

WHEREAS, the General Election was held by the White Mountain Apache Tribe on Wednesday, April 3, 2024, wherein Tribal Council candidates who were certified to the Tribal Council on January 16, 2024, submitted their names to a vote of the people for Council Offices in Districts I, II, III and IV; and

WHEREAS, the Tribal Election Commission has certified to the Tribal Council of the White Mountain Apache Tribe that the General Election is complete and has been carried out in accordance with provisions of the Tribal Constitution and the Election Code of the White Mountain Apache Tribe, and has certified that of the total of 2,980 ballots cast, the following number of votes were received by the individuals listed below whose names were on the ballot for the following offices:

WHEREAS, a true copy of the Election Commission Certification of Election Results is attached and incorporated by this reference; and

WHEREAS, the Tribal Council concurs with the Certification of the General Election Results presented by the Tribal Election Commission and concludes that the Commission's certification should be affirmed and accepted by the Tribal Council.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to Chapter 5 of the Tribal Election Code, the Certification of General Election Results submitted by the Tribal Election Commission for the Council Representatives for Districts I, II, III and IV is hereby accepted and the attached Certification of General Election Results is hereby incorporated into this resolution by reference.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Tribal Council positions which were the subject of this election shall be filled as follows:

DISTRICT I: **Tony F. Alsenay**

DISTRICT II: **Elva C. Lomayaktewa**

DISTRICT III: **Ivan Walker, Jr.**

DISTRICT IV: **Cairo M. Clay**

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on APRIL 4, 2024 duly adopted by a vote of TEN for, ZERO against, and ONE abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1, of the WMAT Constitution, so ratified on November 10, 2021, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
